Spring Trip – New York, NY April 12th -15th, 2023

Dear Sherando Band Students and Parents,

Attached are the projected details for our current planned spring trip to New York City on April 12-15, 2023. I encourage as many of you to attend as possible, and to take advantage of every fundraising opportunity possible to help offset the cost of your trip! For example, Krispy Kreme and Scrip (RaiseRight) sales can be used to significantly reduce the cost of your individual trip amount. Depending upon trip attendance, we may plan to do a group performance if attendance allows. There are many exciting venues, landmarks, shows, and other components planned as a part of this trip! If you are not familiar with some of the attractions, I encourage you to do some quick research and see what great experiences are in store.

<u>SCHOOL GRADES POLICY - PLEASE NOTE</u>: By April 2023, all students are expected to be passing all of their classes in order to travel with the Sherando Band Department. This policy includes both overall grades and term grades.

Please see the second page of this packet for the payment schedule. Make sure to turn in your \$170 (student) / \$150 (chaperone) non-refundable deposit for any student or chaperone reservations you would like to make for this trip. If the trip is canceled due to lack of participation, every effort will be made to ensure that out-of-pocket funds will be returned. Once a student/chaperone signs up and submits their deposit, the deposit is non-refundable; other payments past the deposit are refundable until the final room list is submitted. No refunds will be given after the room list is submitted to the travel company. As always, please let us know if you have any questions.

**\$ - This is an estimated final payment amount. Every effort will be made to keep the trip cost to the listed total amount or below. Depending on the total number of students that we finalize for this trip, the total final payment may be different than the listed amount.

<u>Waitlist:</u> Based on the time that the deposit is received and documented, there may be a waitlist for spots on the first bus. Depending upon the number of deposits received, there may be additional buses planned for the trip. If there are no additional buses, deposits from the waitlist will be refunded.

<u>Refund policy:</u> Once the final room list is turned into the travel company, no refunds will be given after that point. This date varies each year; please see Mr. Cosner w/ questions about this and when this deadline is for this trip.

<u>Grade Passing Policy:</u> If students are not passing their classes in overall and/or term grades, they will not be permitted to travel with the Sherando HS Band Department (per SHS administration). If students are not permitted to go because of failing grades, no refund will be issued due to this.

<u>Band Fees:</u> Students must be current in their band fees to SHSBBA and to FCPS in order to be eligible to attend this trip. Please check with the SHSBBA Treasurer and the SHS Bookkeeper if you need to check the status of those.

<u>Processing of Payments:</u> All payments are processed through the Sherando High School Band Booster Association. As such, all funds are to be submitted to Mrs. Kilkus. All payments are organized and processed by Mrs. Kilkus and the SHS Booster Treasurer. Please let Mrs. Kilkus know if you want to use funds from your student account for the deposit or payments. I have read and understand the description of the travel itinerary, activities and events involved in the field trip, and I give my permission for my child to fully participate in all aspects of the trip.
- I understand that there will be extended times during the trip when my child will not be under the direct supervision of the trip sponsor or an adult FCPS chaperone and that it will be necessary for my child to use his/her independent judgment about unexpected situations and excursions beyond FCPS' knowledge and control.
- I understand that Frederick County Public Schools (FCPS) will not be responsible for any personal property that may become lost or damaged during this field trip, including baggage, money, credit cards, electronic devices, musical instruments, etc.
- I understand that FCPS does not provide medical or accident insurance for student injuries which may occur while on this trip. I authorize and give permission for my child to receive first aid, emergency medical care and transport, medical treatment, and all other care deemed reasonably necessary for my child's health and well-being in case of accident, injury, or serious illness during the field trip. I understand that I will be responsible for any related medical bills, fees, or costs incurred.
- I understand that all FCPS school rules, regulations and policies apply during this field trip. Students who violate any of the school rules, regulations and policies will be subject to consequences set forth by FCPS. In addition, any student who commits a serious infraction while on a field trip may, at the discretion of the trip director, sponsors or chaperones, be sent home at the parents' expense. In addition, depending on the severity or type of incident, law enforcement may become involved.
- I understand that non-refundable tickets purchased by parents and/or students will NOT be reimbursed if the trip is canceled due to inclement weather, hazardous conditions, and/or if national conditions or those in our immediate area make it inadvisable to have students on a field trip. FCPS will provide as much advance notice as possible of any cancellations.
- I further understand that FCPS recommends the purchase of travel accident insurance/trip cancellation coverage and that FCPS will not be responsible for payment or reimbursement of travel fees for any reason.
