### 1. Welcome - Adam Stein

### 2. Treasurer Updates - Sam Kilkus

- Sam recommended approving a band fee scholarship application for a student whose parent just lost a job and is just a couple of hundred dollars over the cutoff. Jennifer Boycourt seconded the motion. The board approved the motion unanimously.

- Sam also asked if there is any reason the boosters' insurance payments couldn't be put on autopay. The board saw none. No vote was required for Sam to proceed with this.
- Jennifer added the boosters need to order bibbers to replace the unusable ones that arrived recently. The replacement bibbers, featuring a snap system for alterations, should be ordered from G2 or a comparable company.

### **3. Old Business**

- Tyler Ende said he just wanted to talk about costs covered by the boosters as opposed to his school-based budget. The discussion also included a desire, among the board, to communicate with the school and other school system leadership to advocate for an equitable budget for Sherando, which is home to the county's largest band/marching band program. The boosters' budget will also be provided to the school principal to aid in this effort.

### **4. New Business**

- The band has a jazz band-only participant, and the board discussed whether to assess a band fee, to be paid to the boosters, for this student. Since the student would use band resources, Jennifer moved to assess a fee of 50% of the regular band fee for any such students. Currently, this is \$75 (50% of the \$150 fee). The board voted unanimously in favor of the motion.
- Golf Cart Maintenance Discussion. Adam shared that information from the owner's manual will be kept with the used golf cart, which was recently purchased from a seller in Spotsylvania County. This information will also be used when documentation of maintenance tasks occurs.
- Scott Kittrell mentioned there is a possibility of selling old drums (5 basses, 2 tenors & 4 snares) which haven't been used in many years, or ridding the band of them through a trade. Vice Principal Darius Fenton, who attended by phone, said he will make sure Principal Karen McCoy is aware of this possibility and will let the boosters know if any issues arise. .
